This transaction represented approximately 0.006% of the issued share capital (excluding treasury shares). Following this transaction, Gregory Hugh Lock's beneficial holding is 590,000 Ordinary Shares, representing 0.52% of the Company's issued share capital (excluding treasury shares), and The Greg & Rosie Lock Charitable Foundation Trust's beneficial holding in the Company is 115,027 Ordinary Shares, representing 0.1% of the Company's issued share capital (excluding treasury shares).
