Computacenter plc (the 'Company')

On 29 October 2024, the Company was notified that The Peter Ogden's Children Trust, of which Peter Ogden is a Trustee, had on 29 October 2024, sold 562,284 Ordinary Shares of 7 $\frac{5}{9}$ pence of the Company ('Ordinary Shares'). These Ordinary Shares have been sold to trusts of which the beneficiaries are members of the Ogden family.

This transaction represented approximately 0.52% of the total number of voting rights in the Company. Following this transaction, The Trust's beneficial holding is 6,818,383 Ordinary Shares, representing 6.41% of the total number of voting rights in the Company.
